Victory! (See attached letter.) On Oct. 14, 1978, Prosident Carter signed the Cranston Bill ammending and clarifying Federal law on home made beer and wine. The letter is from Lee Coe, home brewer, author of a home brewing book, and legislative representative for the Home Wine Merchants Association. In the letter which I received earlier this month(Oct.) he credits the Association, and, "one of our legislative representatives," with informing Senator Cranston and "presenting petitions signed by more than 1,000 people," to the Senate sub-Committee on Finance. I believe the new law we enjoy is a direct reflection of Mr. Coc's efforts. In fact, I believe it was Lee who did everything appear in front of the sub-Cormittee himself:

As President of the Maltose Falcons, as well as being a home brewer myself, I would like to personally thank Lee Coc. Senator Alan Cranston, and everyone who signed the petitions and took time to write the sub-Committee Chairman. It was with the help of all the above, but I feel embedially Lee's efforts that, "did the job for us."

In celebration, I thought it might be fun to combine an inter-club gathering, brew-in and party, with an invitation to Senator Cranston to attend. If any of the other clubs receiving this newsletter are interested, please contact me and we will see if we can get together.

At the last club meeting we had a very successful beer tasting with Rodney Morris in charge. I was impressed with the variety of import beers that I have never seen before. They were very good for the most part. They were largely Pilsner types, so I entered my home mashed bilsner amidst the commercial ones. It hadn't cleared yet, so unlike my last entry in a tasting, the clarity gave it many as home made. I believe Rodney will be doing the tasting again this month. I think he's bringing English beers, ales, and stoats, so if any of the members have a home brew in these categories, you're welcome to enter them. Aside from the tasting, the meeting was quite successful with good attendance, a very lively atmosphere, and a variety of interesting brews.

At the board meeting two matters of importance to the survival of our club were discussed.

(I) Jim Brenneman, our elected editor, has apparently quit the club.At least no one has seen him, or a newsletter from him recently. Therefore, out of his concern, Merlin picked up the pen again, to the delight of many I'm sure.

However, Merlin has done more for the club than should be expected; serving as president, then board member, then editor. 16 Oct 78: Victory! On Oct 14, President Carter signed the Cranston Bill amending and clarifying Federal law on home-made wine and beer. The new law permits "any adult" to make untaxed wine and beer "for personal or family use and not for sale." A one-person household can make a maximum of 100 gallons of each in a calendar year; a household with more than one member can make a maximum of 200 gallons of each. There is no other restriction for either wine or beer.

The phrase "any adult" means that state laws determine how old a person must be to be classified as an adult. Some state laws make it 21 years, others 18, still others an age in between.

The new law eliminates the present restriction allowing only a "head of any family" to make wine at home, and eliminates the present requirement that home wine-makers must register. Home brewers never have had to register, and won't have to do so now.

Senator Alan Cranston of California did the job for us. From the Senate floor, he introduced amendments to a very bad bill and got the Senate to approve them--amendments that turned the bad bill into a good one. Later, the House approved the amended bill. Now, the President's signature makes it a law.

It was the Home Wine Merchants Association that brought the matter to Senator Cranston's attention, and organized a letter-and-petition campaign. One of our legislative representatives presented petitions to a subcommittee of the Senate Finance Committee, petitions signed by more than 1000 people in a couple of months.

The Home Wine Merchants Association has shown that it can be of very real service to its members, and to their customers.
